## INTRODUCTION

The Board of Directors of Friends of Liberia (FOL) would like to express its gratefulness to those who helped support and therefore share in the success of FOL activities summarized in this report for 2023.

In 2023, Friends of Liberia was selected as the recipient of the prestigious National Peace Corps Association (NPCA) Loret Miller Ruppe Award for Outstanding Community Service by an affiliate group, recognizing the publication of the FOL anthology Never the Same Again: Life, Service and Friendship in Liberia (available through our website), edited and promoted by a group of FOL members led by Susan Greisen. It includes 63 true short stories and poems from 50 authors who love Liberia – PCVs, Liberians, and those valued partners who lived in Liberia as medical providers, academics, missionaries, diplomats, and children of the above, as well as individuals who worked in businesses and other development efforts. During 2023 (and 2022) many anthology discussions were held in libraries, bookstores, and book clubs around the country, educating new audiences about Liberia. As background, the anthology was developed as part of 2022 celebrations of the 60th anniversary of the first Peace Corps Volunteer (PCV) group's entrance into Liberia. The activities helped stimulate even more enthusiasm for continuing Friends of Liberia programs. Returned PCVs from that first 1962 group were interviewed in a video guided by FOL former leader Pat Reilly and was shown in Monrovia with now-President of Liberia Joseph Boakai and the current Peace Corps Country Director, Vernice Guthrie, in attendance. That event was a dinner, which the U.S. Ambassador also attended, hosted by FOL as part of a trip back to Liberia by about 20 FOL members. Projects - past, present, and proposed - were visited and outreach was continued through work on other projects begun by former Peace Corps Volunteers.

We encourage you to read through this annual report in order to learn more about the positive impact donations to FOL made in 2023, as well as review management summaries from FOL's volunteer Board of Directors. FOL is a careful steward of funds and at the end of 2023 the FOL Board felt comfortable voting to set up two Endowment Funds that will help insure the sustainability of FOL and its ability to respond again to crises and emergencies that occur. Examples include FOL's past response to the Ebola and COVID outbreaks, and recently to the explosion of a petrol tank that resulted in 52 deaths and about 90 critically injured persons in Totota in December 2023 (Ministry of Health figures reported by BBC).



You will find brief summaries below and more extensive information within about FOL's three ongoing program areas: Family Literacy, Health, and Small Grants.

The FOL Education Committee continued its partnership with WE-CARE International, a Liberian-based (and operated) NGO based in the greater Monrovia area. Of the many projects WE-CARE runs, the FOL Education Committee provides guidance and capacity building for the Family Literacy Initiative (FLI) including a literacy home visitors program and an adult literacy program. In Chapter 4 of this report, please read details about the philosophy, pedagogy, and amazing results of the impactful education programs funded and supported by FOL.

In 2023, FOL Health Team worked with the Liberian Health Team (LHT) to conduct the fourth annual Continuing Professional Development (CPD) workshops for nursing/midwifery faculty and clinicians to maintain and increase competencies. The workshops were held during five days at the Phebe Paramedical Training School in Gbarnga, Bong County. The LHT also accepted the FOL funding and oversight of an award to Phebe Hospital to assist with extraordinary expenses related to the care of the Totota gas tanker explosion victims. Please see Chapter 5 for details about all of FOL's Health Program work in Liberia in 2023.

The FOL's Small Grants Committee reviewed more than 46 proposals in 2023 and selected four applicants to receive small grants. These grants supported programs in teacher training, empowered and enhanced braille literacy among visually impaired persons in rural Liberia, and helped to renovate and expand the clinic and triage area at a maternal and childcare facility. Chapter 6 provides a full accounting of the FOL Small Grants Program work in 2023.

In December 2023, the FOL Board met in person in Zionsville, IN (thank you, Sally!) for its annual program review, budget development, brainstorming, and relationship-building. We have already completed our 2024 in-person board meeting and planning session in Washington, DC at the National Peace Corps headquarters on Saturday, September 21, 2024. Interested FOL associates are always invited to attend and observe, ask questions, and make suggestions at our quarterly or annual Board of Directors meetings.

With respect to FOL membership, we understand that the gap of 20 years without Peace Corps during the civil war, and recent evacuations due to Ebola and COVID, will catch up with FOL as the early PCV group members pass on. We have plans to re-energize our membership committee and to analyze and plan how to maintain and expand our critical membership base.

## **COMMUNICATIONS**

#### FOL Communications Committee Annual Report - 2023

A new Communications Chair assumed their position in June 2023. Craig's work focused on learning past efforts regarding FOL communications and getting up to speed with the communication vehicles that FOL currently uses (i.e. email blasts via MailChimp, Facebook, and Instagram).

Upon receiving word from NPCA that FOL was a finalist for NPCA 2023 Loret Miller Ruppe Award for Outstanding Community Service for our Anthology project, "Never the Same Again: Life, Service, and Friendship in Liberia", email blasts were issued to membership encouraging members to attend the NPCA Annual General Meeting and to vote, as instructed by NPCA, for an award finalist. In October, NPCA informed FOL that we had won the award and Communications via email blasts were issued regarding this major milestone. The FOL website was updated to the tab menu so information regarding our Anthology project and how to buy our book is clearly presented.

The Communications Committee (myself and Alicia Falsetto) met, developed, and issued a strategic communications plan for 2024. The plan presents goals for FOL for communications across a board range of audiences and specifies message content, delivery methods, frequency of communications, project name and other details. ## **EDUCATION**

#### The Family Literacy Initiative (FLI)

This year was the 8th year of the Family Literacy Initiative (FLI). WE-CARE, FOL, and HIPPY International launched the FLI in November 2015 after a survey by FOL members indicated that the most significant unmet educational need in Liberia was early childhood education. More specifically, the preparation of preschoolers in literacy and other basic skills needed to thrive in school.

The FLI is a partnership between FOL, the WE-CARE Foundation, and HIPPY International. The FLI has two components: the HIPPY Home Visitors program and the Adult Literacy Program (ALP). The HIPPY Home Visitors program uses the HIPPY curriculum to provide parents with training, educational activity packets, and other resources to help improve their child's literacy and readiness for school. The training and resources are delivered through home visitors, which WE-CARE employs.

The ALP is a series of literacy classes using a curriculum designed to supplement the HIPPY curriculum for those parents and other adults who want to improve their literacy as they help their children improve their readiness for school. In recent years, the ALP has also served a number of adults who are not an FLI caregiver. Miriam Westheimer of HIPPY International also provides resources and technical support as needed.

WE-CARE serves as the on-the-ground implementer and facilitator, adapting the HIPPY curriculum to a Liberian context, training and coordinating the home visitors, and overseeing the program. In December 2022, year 7 of the HIPPY Home Visitors program ended with 254 children and came to a close. WE-CARE ended last year with the ALP program with 106 level one learners and 42 level two learners.

#### **The HIPPY Home Visitors Program**

HIPPY is an international early childhood development program grounded in the belief that learning begins at home and parents can play a critical role as educational partners with schools. It is widely known that children are more successful when parents are engaged in their learning. HIPPY is designed to help parents prepare their preschool children for success in school and life and to equip parents with the tools, skills, and confidence they need to support their children's learning at home successfully. The Education Committee's dedicated monitoring and evaluation team has been working on expanding our previous report tracking of the graduates from the HIPPY program.

For year 8 of the HIPPY Home Visitors Program, 274 families started the program, and 259 families completed the program. As a whole, the FLI continues to have a very high student retention rate. This year, 53 children graduated from year 3, and the graduation proceedings were held in early December. WE-CARE continued the program in West Point, Cadwell, Duazon, Neezoe, and Myamah Town. In 2022, Myamah Town was slightly delayed compared to the other communities. This year, they were on track with the other communities.

Comic Relief-US, a US-based non-profit focused on ending poverty, continued to fund the FLI this year but delivered some unfortunate news. Comic Relief-US lost a major funder and, as a result, had to cut the value of their grants by 50% across the board for 2024.

This means that the FLI will have to operate at a reduced capacity unless additional funding is found. In better news WE-CARE worked with a filmmaker this year to create a short 15-minute documentary on the HIPPY Home Visitors program to spotlight it.

#### Early Childhood Development Centers (ECD)

In 2022, the FLI program added a new community, Myamah Town. This town is actually a collection of about five smaller communities in rural Montserrado County with Myamah Town being the largest and most central community. These communities were added using extra funding provided by the COMIC Relief grant, which WE-CARE won in 2022. Early on, when working in Myamah Town, WE-CARE realized that there was a lack of meeting space for the HIPPY home visitors group meeting and for the ALP classes. WE-CARE quickly developed a plan to solve this problem: converting unused classroom space into an ECD center in one community and the community building space in another. Both of those spaces were finished this year, and their operation began.

#### Adult Literacy Program (ALP)

The ALP is a series of group meetings designed to help HIPPY parents improve their English literacy and numeracy skills. The ALP curriculum is designed to work with the HIPPY curriculum, but the classes are not exclusive to HIPPY parents, though HIPPY parents are given priority in the program.

There are two levels of the ALP. Level One is for parents who have very little literacy skills, while Level Two is designed as a continuation of Level One and is designed for parents who already have some basic literacy skills. The curriculum writer and the ALP coordinator, James Cooper, are still actively developing the Level Two curriculum.

One of the major challenges this year was attendance. Attendance, particularly with the ALP classes, was lower than desired due to the ALP learners involvement with the Presidential election held in Liberia this year.

Even with the challenges the ALP was successful this year with 76 level 1 learners and 33 level two leaner completing the program. The graduation programs for ALP were held in each community in early December.

#### T racking Study

WE-CARE and the Education Committee's Monitoring and Evaluation group has been working on tracking study. Cohort 1 students graduated from FLI/HIPPY in December 2018. Data was collected on these students' academic performance during the 2022/2023 academic year. A total of twenty-five different teachers and twenty-eight schools were involved in the study. A total of 47 students were in this cohort and 62% (29 of 47) of them were enrolled in schools and were tracked. Preliminary results show that students attended school regularly, and that 20.6% were absent for just one or two days the entire year. By the end of the year, most students were promoted to the next grade, 83% (24 of 29) and 17% (5 of 29) being retained.

This year, the FLI tracking study continued. The goal of this study is to gather data about how the students who have graduated from the HIPPY program are doing in school and compare them with peers in the same classes. These results will be included in a final report, which will provide a detailed analysis of the academic progress and behavior of Cohort 1 students.

#### **Publications**

In 2022, the Education committee submitted a proposal to write a chapter for a UNECSO publication that will focus on early childhood literacy programs worldwide. The proposal was accepted, and this year, the finalized chapter was given to UNESCO for publication in 2024.

The Education Committee released the 2022 Landscape Paper in January of 2023. This year, the landscape paper features organizations working in Liberia that focus on education. The 2023 paper will be published over the summer of 2024.

#### Peter Town

Unfortunately, in 2022, the ongoing work in Peter Town came to a standstill due to unforeseen issues with WE-CARE continuing to work in the town. This was beyond WE-CARE's and the committee's control. Since then, the committee has been looking for a way to restart the work in Peter Town, even if that means the Peter Town teachers traveling somewhere for training.

## Health Committee Annual Report 2023 Introduction

The Friends of Liberia Board (FOL) requested in 2014 that a small group of FOL members explore establishing a FOL Health Project. Late in 2015 a health project concept was identified. In 2016 Friends of Liberia Health Team was created with an FOL Liberia Health Team (LHT) and a FOL US Health Team (USHT). An FOL Board Member position was established to serve as the liaison between the Health Team and the FOL Board.

#### Goal

The goal of this project is to identify specific areas where faculty members from the schools of nursing and midwifery need to improve their teaching competencies. This will help them do a better job of preparing nurses and midwives to work in Liberia, and in turn improve the level of health care in Liberia. As nurses and midwives provide the bulk of the health care in Liberia, it is extremely important that these health care workers in Liberia receive the best quality of education while obtaining their initial instruction and throughout their nursing and midwifery careers.

Initially, the FOL LHT conducted a needs assessment survey in order to identify the specific areas of need. The review of the data demonstrated that there was a strong need for continuing professional development workshops to increase and improve the teaching skills of the faculty at the schools of nursing and midwifery.

Each year, the FOL LHT conducts needs assessments with both faculty and clinical members from accredited Liberian nursing and midwifery schools to determine that year's workshop curriculum. This keeps the curriculum relevant to the participants each year.

## **Project One: Continuing Medical Education** 2020

Pilot Faculty Workshop: The pilot weeklong Faculty Continuing Professional Development Workshop was very successfully held in January 2020 at the Phebe School of Nursing, Bong County with twenty faculty members from twenty Liberian Board for Nursing/Midwifery accredited schools. The goal of this workshop was to increase the knowledge base and proficiency of nursing and midwifery teaching faculty in the areas of Evidence-based Research, Evaluation and Testing and Leadership and Management.

## <u>Second annual Faculty Workshop and Pilot Clinical Workshop:</u>

Following the successful pilot of the faculty workshop, the LHT decided to add a second week for practicing nurses and midwives after receiving some feedback in the needs assessment.

In January 2021, the LHT conducted a weeklong **Faculty Continuing Professional Development** Workshop at the Phebe School of Nursing in Bong County for twenty faculty members from twenty schools of nursing and midwifery in Liberia and a member of the Liberian Board of Nursing and Midwifery. The focuses were curriculum design and development, writing research proposals, test items analysis/banking, evaluating educational programs and writing objectives using the backward design. This was followed by a second weeklong Clinical Professional Development Workshop to enhance the clinical competencies of practicing nurses and midwives. They had 18 nurses/midwives in attendance, as well as several hospital Directors of Nursing and Midwifery and a representative from the Liberian Nurses Association was also in attendance. The main focuses were documentation, nursing processes (especially for critical patients), evidence-based clinical practice guidelines, customer service and performing emergency procedures.

#### 2022

Third Annual Continuing Education Workshop: For the third annual workshop, the decision was may the LHT to plan a single week long workshop. Faculty attended a two-day workshop, followed by a single day joint session with practicing nurses/midwives, followed by a two day workshop for the practicing nurses/midwives. The workshop was held at the Phebe School of Nursing. Twenty nursing/midwifery faculty plus staff from the Liberian Board for Nursing and Midwifery (LBNM) attended a three-day workshop and twenty nursing/midwifery practicing nurses/midwives including the President of the Liberian Nurses Association (LNA) attended a three-day workshop. The main focuses of this workshop included testing and evaluation, education through distance learning, program evaluation and accreditation, linking theory with clinical experience, quality improvement in the clinical setting, decision-making and problem solving, and transitioning graduate nurses/midwives to practice. This year, the team added an in-person

follow-up assessment at institutions that allowed participants to collect data on the impact of the workshops, and conduct an on-site needs assessment for future workshops.

#### 2023

Fourth Annual Continuing Education Workshop: After feedback from the participants of the 2022 workshops and needs assessments, the decision was made to continue with the current format of the workshop with a two day workshop for faculty, a single day joint session with practicing nurses/midwives, followed by a two day workshop for the practicing nurses/midwives. In addition, through on-site assessments after the 2022 workshop, it was determined that up to 90% of participants of the previous workshops had shared workshop resources in their respective institutions either through uploading of workshop resources onto personal or institutional computers or more formally through organized workshops.

The 2023 workshops had twenty-two faculty from twenty-one schools and twenty-six clinicians from twenty-six hospitals in attendance. The focus of this year's workshop included teaching-learning strategies, test construction and analysis, linking classroom and clinical practice, neonatal resuscitation, workplace ethics and effective communication.

Funding for the 2023 workshops was obtained from a grant from the FOL Board, donations to FOL designated for the FOL Health Project, and donations made through a GlobalGiving campaign.

#### Planning for 2024 workshops

Due to the success of the joint workshop, the decision was made to continue on with this format. The LHT spent the second half of 2023 preparing budgets and curriculum based on feedback from previous groups.

Health Ministries.

**COVID Committee:** 

While FOL was actively involved in COVID-19 response in Liberia in 2020, this was primarily done under the small grants committee. When there was a rise in COVID cases in Liberia over the summer of 2021, the board formed a sub-committee which fell under the Health Team. The Committee formed a partnership with Global Health Ministries (GHM) who had received PPE donations, including masks, face shields, gloves, gowns, sanitizers, and soap. Together, the Committee and GHM were able to send a 40 ft shipping container carrying hundreds of thousands of supplies that arrived in Liberia in February 2022. Due to a pleasant surprise of excess PPE, a second container was shipped and arrived in March 2022. Materials have started to be distributed to 23 schools of nursing and midwifery and 21 clinics and hospitals across Liberia. LHT members have played an instrumental role in facilitating the distribution of materials in coordination with staff at Phebe Hospital where the shipments are being stored.

#### **Small Grants Committee 2023 Annual Report**

During 2023, the Small Grants Committee has improved the Small Grant Application to increase accessibility as well as the application evaluation process to be more streamlined and transparent. Applications are evaluated on Need, Reach, Organization's Track Record, Budget, Sustainability and Impact. A rubric has been designed to accurately, consistently and transparently evaluate applications for small grants. The committee is working on developing monitoring and evaluation requirements and documentation to better support grantees and capture the impact of these projects. The committee continues to receive and review many applications (~15 applications per quarter). Descriptions of the projects funded by the Small Grants Committee during 2023 can be found below:

- 1. Refuge Place International was granted \$3,000 in the fourth quarter of 2023 for Integrating Community Health Workers and Basic Hygiene Promotion to Improve Hygiene in Schools and Communities. The program is a healthcare model for Liberia's rural poor and urban slums with the objective of lowering the country's maternal, neonatal, and child death rates, thereby promoting reproductive health and making high quality healthcare available to all.
- 2. Dignity Liberia was awarded a \$3,000 grant in the third quarter of 2023 that was used to help with the building of a maternity waiting home in Todee Junction, Montserrado. With the availability of this home they hope to reduce the incidence of obstetric fistula. The committee hopes that this partnership will lead to more positive partnerships in the future.
- 3.. African Youth Development Action Project, Inc. (AYDAP) was awarded a \$3,000 grant to conduct teacher training in Sand Beach Junction, River Cess where none of the educators had training in education. Because of its rural location and hard to reach, it was difficult for them to find trained teachers.

The training was recently completed and an additional application was submitted for continued training and C certification for the participating teachers.

4. Imani House, Inc. received a \$3,000 grant from FOL earlier in 2023 that was used to renovate and expand the clinic and triage area in Jahtondo Town, Brewerville, Montserrado. This addition has allowed more patients to be served and reduced the wait time, thus ensuring timely treatments.

#### Outcomes met:

- 1. All temporary walls were replaced with concrete walls
- 2. Contractors replaced four termite damaged doors
- 3. The roof was repaired to prevent leaks
- 4. One commode and one sink were purchased and installed
- 5. Four new permanent windows were installed in the walls to replace the temporary windows
- 6. Workers painted the exterior and interior of the renovated building
- 7. We can now provide services promptly to patients who need emergency treatment.

Project Title: Renovation of Imani House Clinic Triage Space & Intake Area Location of Clinic: Jah Tondo Town (Brewerville), Brewerville Estate Road

Describe the target audience, what needs to be addressed, and the number of beneficiaries from this project: This project included general repairs and minor expansion to the Triage facility at the IMANI HOUSE Family and Children Clinic. We hope that it will help the clinic to serve a total of 12-16,000 women and children(and men) who reside in District 17 (primary Brewerville) and its surrounding areas, which include parts of lower Careysburg, Cheesemanburg, Royce Ville, and part of Bomi County that borders the Po River.

We expect the number of patients to increase after we renovate/expand our short-term bed capacity from two to four beds by renovating our triage space. A four-room triage space was erected previously with bamboo and tarpaulin as a temporary structure during Ebola. This space needed to be modified/renovated into a permanent space to provide safe accommodations and offer two beds for a short stay.

Given population trends and expectations for increasing patients accessing our services, adding two additional bed spaces would increase our short-stay capacity from two to four beds while stabilizing our screening room and waiting space in the triage area. The renovation will increase our capacity to address emergency treatment. The main goal of this project is to provide a safer, more hygienic environment to triage more patients than we currently can while keeping patients and staff safe.

#### **Outcomes**

- 1. All temporary walls were replaced with concrete walls
- 2. Contractors replaced Four termite damaged doors
- 3. The roof was repaired to prevent leaks
- 4. One commode and one sink were purchased and installed
- 5. Four new permanent windows were installed on the walls to replace the temporary windows
- 6. Workers painted The exterior and interior of the renovated building
- 7. We can now provide services promptly to patients who need emergency treatment.

#### Timetable:

Our timeline for completion was three months. We received grant funds in September and completed the project by December 31, well within three months.

Project Evaluation.

- As this is a renovation/expansion project, coupled with Imani House Inc.'s 33+ years of providing programs in Liberia, sustainability has no issue.
- The project will be preserved by regular maintenance and repairs through income from our clinic fees and ongoing partner support.

#### Annual Development Report 2023

With the wonderful gift received from Sally Gosline Humphrey, RPCV Group III, in September 2022, efforts were finalized to establish an endowment fund. Three board members interviewed staff with the Greater Washington Community Foundation. After careful consideration at the June 2023 board meeting, the FOL Board voted to establish two endowment funds with The Greater Washington Community Foundation.

These two funds have different purposes. The first fund has restricted access, meaning that FOL will only be able to use the interest that is earned off the principal that is carried in the fund, up to five percent per year after being in the account for three years. The second fund has more flexibility. Should an emergency situation occur in Liberia, FOL could petition the Greater Washington Community Foundation with a request for a special release of funds for a specific purpose to address an emergency situation. The FOL Board will be working on an internal endowment policy in 2023 to outline the future use of our endowment funds.

The two funds are called 1) The Friends of Liberia Legacy Circle Fund, with the purpose of supporting education, economic, and humanitarian programs in Liberia; and 2) The Friends of Liberia Emergency Fund, with the purpose of supporting programs and efforts in Liberia in times of emergencies such as Ebola, Covid, Civil War, environmental destruction, natural disasters, or other such challenges to daily living in Liberia.

The Rolander Family Foundation again supported our HIPPY Home Visiting Program with a generous \$5,000 grant in 2023. Their long-time support deserves special recognition, with a warm thank you to Stephanie Vickers for her efforts to help secure this donation every year. Records show that Rolander has been giving this support since 2005, and we are so grateful for their dedication to FOL's family literacy work.

A special thank you to Jim and Pat McGeorge for their continued generous support, both financial and otherwise, of our Health Program. And of course, thanks to Cori Maund and her work while 40+ weeks pregnant to finish writing the Global Health Ministries' Grant, and to the Liberian Health Team under Dr. Edwin Beyan's direction - all are such dedicated people, and we are so fortunate to have them on our team.

In 2023 FOL had 286 donors, thirty-five of whom were new donors, and eighty-one were donors that had not given in 2022. Sadly, we continue to lose some of our older member donors from our earlier Peace Corps Groups. FOL members can assist in our funding efforts by encouraging members from their own PC group or cohort to join them in donating to FOL's many programs.

Our total donations for 2023 were broken down between General Fund at \$34,275.03; Adult Literacy at \$445.00; Family Literacy at \$16,813.33; Health at \$17,264.11; and Small Grants at \$2,424.97, for a total of \$71,222.44. Through Global Giving, we raised a total of \$6,852.14 broken down between Health at \$4,187.36 and Family Literacy at \$2,664.78. When you consider the hundreds of children and families in the HIPPY Home Visiting Program, the faculty and midwives trained yearly during the Liberian Health team's annual workshops, and the number of individuals served by the small grant awards, every donation to FOL is a true investment in Liberia. This is such magnificent work with such remarkable results, and donors to FOL should be enormously proud of what their contributions have done during 2023. We thank all of them for their support.

We are still in need of more volunteers to help with our committees. Interested individuals should contact an FOL Board member for information. Any, and all of them, would be happy to answer questions or put you in touch with the right person.

#### **2023 Annual Report Financial Section**

In addition to meeting our annual obligation to submit financial information to the IRS (Form 990, which will be published on our website), our financial statements provide FOL members and donors a better understanding of how the organization is doing from a financial perspective. They also help our board of directors do multi-year planning and budgeting. As good stewards of member and donor contributions, we believe it is essential to be transparent in all financial matters.

#### Statement of Financial Position

The Statement of Financial Position as of December 31, 2023, shows total assets of \$366,988.57, consisting mostly of cash in the bank of \$316,988.37. Additionally, FOL has an Endowment Fund Investment of \$50,000, representing about 14 percent of its total assets (see the Development section above for more information on this investment).


FOL has no outstanding liabilities. Total assets equal its Total Equity/Total Surplus.

#### Statement of Income and Expenses

The Statement of Income and Expenses for the year ending December 31, 2023, shows a net loss of \$7,754.49, indicating that expenses for the year exceeded income. A summary of income and major expenses for the year follows.

#### Income

Income from individual and business donations totaled \$79,989.84, most of which was allocated to FOL's Program Services, including 45 percent to Family Literacy, 19 percent to Small Grants and 27 percent to the Health Fund. The net balance after program services amounted to \$6,938 (9%) which was used to pay for other operating expenses.



#### **Expenses**

FOL's operating expenses consist of Fundraising Expenses of \$808.30 (5 percent) and Management and General Expenses of \$14,329.44 (95 percent), for a total of \$15,137.74.

Software subscriptions, including Kindful, Drop Box, Mail Chimp, Zoom and others, accounted for 38 percent of the Management and General expense, while printing, mailing and other subscriptions accounted for 32 percent of these expenses. Board insurance (8.4 Percent), bank and investment fees, office expenses, business licenses/subscriptions and other smaller expenses were also paid.

Total Net Loss, or the amount that annual expenses exceeded annual income in 2023, amounted to \$8,196.90. Interest income of \$442.41 offset part of this loss, bringing the total net loss for the year ending December 31, 2023 to \$7,754.49.
